NARRATIVE:

On Sunday, February 19, 2017 at approximately 2002 hours, the New Milford Police Department dispatch center received a 9-1-1 call reporting a car vs. pedestrian crash on Kent Road (Route 7), in front of Big Y. New Milford police officers, as well as members of the New Milford Ambulance Corps, Water Witch Hose Company and Campion Medic 4 responded to the scene. The New Milford Police Department Crash Reconstruction Team was called in to investigate.

The subsequent investigation determined that a male pedestrian attempted to cross Kent Road from East to West in the area of the Savings Bank of Danbury. The pedestrian was struck in the Southbound lane by a 2006 Subaru Impreza. The Impreza was driven by Melanie R. Fay, age 23, of New Milford. The pedestrian was transported to the Danbury Hospital Emergency Department by New Milford Ambulance. The pedestrian is listed in critical condition as of this time. The pedestrian was identified as David Antonio Ramirez-Ramirez, age 45.
