Mr. O'Brien requested that a letter be sent to each appointee authored by Chief Boyne similar to the letters sent to the members historically, detailing the limitations of the positions. Mayor Murphy noted that she has reviewed the limitations with the Chief for both Lake Authorities.

Mayor Murphy updated the Council on the Bike Trail progress. She said the Housatonic Railroad had spoken in favor of the Railroad Crossing at Sega Meadow, at the meeting in Hartford. She added that Representative Chapin was successful at passing the legislation through the House, and that the legislation is now awaiting Senate approval.

7. <u>VILLAGE CENTER ORGANIZATION</u>

Discussion and possible action on request to close off the southern cross – over of the Green for the set up, duration and break down of the 16th Annual Outdoor Art Festival on the Green Saturday June 18 (10am-6pm) and Sunday June 19, 2011 (noon-5pm.)

8. PARKS AND RECREATION

Mr. O'Brien moved to approve the request to authorize the appropriation, as a loan, due to/from the General fund to the Parks gift fund in the amount of \$75, 217.00 for costs associated with fulfilling the GE Grant to be reimbursed to the General fund when the project is

complete. The motion was seconded by Mr. Mullen and passed unanimously.

Mr. O'Brien asked why the money was being placed in the gift fund. Mayor Murphy explained that is the line that Parks and Recreation uses for donations and grant money for projects. Mr. O'Brien said going forward he would like feedback from Finance Director regarding whether grant monies should be kept in a separate account. He noted the same would apply for the next item on the agenda as well. Ms. Buck-Taylor asked what the anticipated completion date was for the project. Mayor Murphy noted the completion is slated for this year; the exact timing will however depend on weather conditions.

Discussion and possible action on request to authorize the appropriation, as a loan, due to/from the General fund to the Parks gift fund in the amount of \$1,600.00 for costs associated with fulfilling the DEP Equipment Grant to be reimbursed at 80% to the General fund when the project is complete.

Mayor Murphy explained that the grant for this item is \$2000.00. The reimbursement however is \$1600.00. She said this was the verbiage requested by Finance Director, Ray Jankowski, per the auditor's recommendation.

Attorney DiBella questioned why the Town is looking to make a loan unto itself. He noted that the Charter does not allow for that. He said that he did not understand where the authority is for authorizing the appropriation for a loan to ourselves. Mayor Murphy responded that it is an accounting transaction. The Council discussed that the item is essentially a temporary transfer. Attorney DiBella noted that it should be written as a temporary transfer to be reimbursed and replenished by way of grant. He said the Town has no authority to loan money without a bond. Mr. Mullen asked if Attorney DiBella was recommending that the monies be associated with the contingency account or another account. Attorney DiBella said he wouldn't make a recommendation about a particular account as he does not have the authority or understanding to. He said he however cannot authorize a loan. Mayor Murphy said that she would explain to Mr. Jankowski that the verbiage should read "temporary transfer". Mr. O'Brien asked that the language be added per the recommendation of the Town Attorney to the motions and minutes for the Council's review at the next meeting.

Mr. O'Brien moved to amend his motion as the approval of the request to authorize the appropriation, as a temporary transfer, due to/from the General fund to the Parks gift fund in the amount of \$75, 217.00 for costs associated with fulfilling the GE Grant to be reimbursed to the General fund by way of grant when the project is complete. The motion was seconded by Mr. Mullen and carried unanimously.

9. PUBLIC WORKS

FIRST SUPPLEMENTAL AGREEMENT TO THE ORIGINAL AGREEMENT BETWEEN THE TOWN OF NEW MILFORD, CONNECTICUT AND DIVERSIFIED TECHNOLOGY CONSULTANTS, INC. (DTC) FOR CONSULTING ENGINEERING INSPECTION SERVICES FOR REHABILITATION OF LOVER'S LEAP BRIDGE OVER HOUSATONIC RIVER

STATE PROJECT NO. 95-222, FEDERAL PROJECT NO. STPE-2761(12)

THIS AGREEMENT, concluded at New Milford, Connecticut this _____day of ______, 2011 by and between the Town of New Milford, acting herein by Patricia A. Murphy, Mayor, 10 Main Street, New Milford, Connecticut, duly authorized, hereinafter referred to as the Municipality, and Diversified Technology Consultants, Inc. (DTC) acting herein by A. Graham Curtis, Vice President and Chief Operating Officer duly authorized with an office and place of business at 2321 Whitney Avenue, Hamden, Connecticut, duly authorized to practice professional engineering in Connecticut under the provisions of Chapter 391 of the General Statutes of Connecticut, as revised, hereinafter referred to as the Contracting Engineer.

WITNESSETH, THAT,

WHEREAS, the Municipality and the Contracting Engineer executed an Agreement entitled "Agreement Between the Town of New Milford and Diversified Technology Consultants for Consultant Engineering Inspection Services for the Rehabilitation of Lover's Leap Bridge over Housatonic River" dated July 17, 2003 hereinafter referred to as the Original Agreement, and

WHEREAS, the Municipality has retained the Consultant to perform certain consulting engineering inspection services related to rehabilitation of Lover's Leap Bridge over the Housatonic River, New Milford, Connecticut, and

WHEREAS, a 95-day time extension has been granted to the Municipality's construction contractor to complete construction of the project, and

WHEREAS, additional consulting engineering inspection services by the Contracting Engineer have been determined to be required in conjunction with said time extension, and

WHEREAS, the maximum amount which the Municipality shall pay to the Contracting Engineer under the terms of the Original Agreement, which amount is One Hundred Seventy-six Thousand Nine Dollars (\$176,009) has been found to be insufficient and needs to be increased, and

NOW, THEREFORE, KNOW YE THAT, THE PARTIES HERETO AGREE TO AS FOLLOWS:

I.) That Article (37) of the Original Agreement is hereby deleted and the following substituted in lieu thereof:

(37) That subject to the limitations stipulated in paragraph (38), the Contracting Engineer shall be paid in the following manner for all work performed in accordance with the terms of this Agreement with exceptions of those services for which a different method of payment is stipulated:
(a) the Contracting Engineer's actual costs, including the actual costs of approved subcontractors, plus (b) a fixed fee for profit of Thirteen Thousand Two Hundred Six dollars (\$13,206) plus (c) direct non-salary costs directly allocable to the Project of Twenty-Five Thousand One Hundred Ninety-Two dollars (\$25,192).

The Contracting Engineer may bill direct cost for transportation and subsistence (if applicable) in accordance with the Standard State Travel Regulations-State Managers limiting amounts and transportation (mileage) will conform to OPM's General Letter 97-1 dated November 21, 1996.

The Contracting Engineer hereby acknowledges and agrees to comply with policy enumerated in Administrative Memorandum No. 104 dated August 28, 1984 Re: "Procurement and Property Management of Equipment Purchased by Construction Inspection Consultant Engineers".

Actual costs shall be: (1) salaries of employees directly chargeable to the Project at rates not to exceed those shown in paragraph (50); and (2) burden, fringe and overhead costs properly allocable to the Project. For 2003, the percentage for field office operations will be no higher than 109.38. For 2004, the percentage for field office operations will be no higher than 104.78. For 2005, the percentage for field office operations will be no higher than 111.88. For 2006, the percentage for field office operations will be no higher than 109.82. This percentage will be revised annually based on a State approved audit of burden, fringe and overhead costs of the previous year's experience. In no case will the total of burden, fringe, overhead and profit exceed 125% of payroll. The term "Salaries" as used in this Agreement shall mean the gross wage or payment made to employees before deductions for employee paid taxes and fringe benefits. The final determination of the sum to be paid for actual costs will be made following an audit of the Contracting Engineer's records. The certified payroll shall cover salaries computed at straight-time rates. The certified percentage for burden, fringe, and overhead shall be applied only to the "straight-time" portion of overtime pay. No payment shall be made to partners or officials of the firm for those services unless they are engaged in production work in which case compensation will be made at production rates.

II.) That Article (38) of the Original Agreement is hereby deleted and the following substituted in lieu thereof:

(38) That the maximum amount which the Municipality shall pay to the Contracting Engineer for all work performed under the terms of this Agreement, excepting work for which payment is provided in paragraphs (42) and (48) shall not exceed Two Hundred Three Thousand One Hundred Thirty-Two dollars (\$203,132) unless revised under the terms of Article (49) of this Agreement. The maximum amount will not be revised unless there is a substantial change in the scope or character of the work to be performed by the Contracting Engineer which would justify a revision of this figure; or if, for any reason, the Contracting Engineer does not or cannot start his work prior to or in sufficient time to meet the construction contractor's schedule of operations, and the Municipality finds it necessary to provide certain inspection and survey services, the limiting amount and fixed fee shall be reduced an equitable amount to reflect the Municipality's expense in connection therewith. III.) That Article (50) of the Original Agreement is hereby deleted and the following substituted in lieu thereof:

(50) That the maximum hourly rate for each classification of employee to be used on the Project shall be as follows and additional classifications if required must be submitted to the Municipality's Project Engineer for prior approval by the Negotiations Committee. The Project Manager classification is Federal Aid non-participating.

The above maximum hourly rates of pay shall be subject to renegotiation should the work required under this Agreement not be completed by September 22, 2006. Any adjustment to the maximum hourly rates stated above shall apply only to such services as may be rendered subsequent to the date of renegotiation. Overtime work, when authorized by the Municipality, shall be paid for by the Municipality at "straight-time" rates except when otherwise required by law or regulation or when otherwise approved by the Municipality. The surcharge for burden, fringe and overhead shall be applied only to the "straight-time" portion of any overtime pay.

Subject: Proposed Resolution of Litchfield County Towns to Honor LOCAL African American Revolutionary War Soldiers and Support a National Memorial in Washington, D.C.

Dear Litchfield County Town Officials:

Liberty Fund D.C. invites your town to honor more than 820 African American soldiers, sailors and patriots of the American Revolution from Connecticut. We are asking all towns with patriot ancestors to consider a resolution acknowledging these trailblazers and voicing support for an entirely citizen-funded national memorial in Washington.

The National Liberty Memorial will honor between 5,000 and 10,000 patriots of the American Revolution. Connecticut was home to 16 percent of the 5,000 known African American patriots who served in official capacities. Senators Joe Lieberman and Charles Grassley will introduce legislation in Congress later this week to honor these forgotten American heroes.

Five hundred sixty-two (562) of the 820 patriots from Connecticut are connected by birth, enlistment or residence to 80 towns, including 52 patriots from 13 towns in Litchfield County. Seventeen (17) are from Woodbury – the highest number in Litchfield County. Yours, or any of the remaining 89 towns, could prove a connection to the 258 listed as "no residence given." As extensive as the list is, many more could be unaccounted for and awaiting discovery in Litchfield County and the nation.

The recent inauguration of new tools to explore Connecticut's Freedom Trail makes this timely. Governor Dannel P. Malloy was recently quoted saying, "the state's history is too often overlooked, whether it's Connecticut's role in the American Revolution or Industrial Revolution." Future research will lead to discoveries of complex connections between people, places, events and generations. These discoveries could add numerous new sites to the Trail. History, tourism and unity will be promoted through the recognition of shared principles and a common destiny.

<u>A draft resolution and fact sheet are attached.</u> The latter includes a list of local patriots, a tabulation of patriots by town, and a state map showing the 80 hometowns. An article from the Hartford Courant explains the origins of the project in Plainville, Connecticut where I grew up. Years later, the clues I finally comprehended led me to discover my own family's diverse heritage and connection to the African Americans of the Revolutionary War.

Already 18 counties in my adopted state of Virginia, the Virginia Association of Counties (VACO) and the city of New Orleans have approved resolutions. In the weeks ahead, other cities and counties will participate. However, it is appropriate that the actual campaign begin in earnest in Connecticut.

Connecticut has been laying the groundwork since the state's American Revolution Bicentennial Commission published *Connecticut's Black Soldiers* by David O. White in 1973. Milford erected a memorial to six patriots in 1976. The Freedom Trail contains multiple Revolutionary War era sites and members of Connecticut's congressional delegation have championed this cause for 26 years.

Throughout the Civil Rights Movement, I was unaware that slavery touched the soil where I played as a child. The Charles Norton House that concealed runaways from the south (now on the Freedom Trail) was just a block away. Children and adults of every color would benefit by knowing what I, and my contemporaries, did not know.


I did not know that thousands of the enslaved sought freedom 154 years before the birth of Dr. Martin Luther King. In the process, they helped to create the United States and the churches and self-help groups that have written the story of our nation.

This resolution will suggest to your citizens ways to envision the history as a tool to perfect our democracy.

I hope you will consider this request.

The Hometowns of Connecticut's African American Revolutionary War Soldiers, Sailors and Patriots



Quick Facts about Connecticut's African American Soldiers and Sailors of the Revolutionary War

- ✓ At least 820 African American soldiers, and seamen (patriots) served in the Revolutionary War from Connecticut. (This does not include those who provided civilian assistance or demonstrated a personal desire to be liberated from enslavement. Many men, women and children ran away or filed freedom petitions with courts and the General Assembly.)
- Connecticut's 820 patriots represent 16 percent of the known 5,000 who served from the 13 colonies and territories.
- ✓ Some estimate that up to 10,000 African Americans served In the Revolutionary War.
- ✓ At least 562 African American patriots are connected by birth, enlistment or residence to a town.
- ✓ At least 258 African American patriots are not associated with a town.
- ✓ Of Connecticut's 169 towns, 80 are connected to an African American patriot.
- ✓ At the time of the Revolution, African Americans accounted for 2.6 percent of the population of Connecticut, not including American Indians.
- ✓ According to the Connecticut census of 1774, 2,883 African American males of all ages resided in six counties in the state. (Middlesex County and Tolland County were created in 1785.)
- ✓ If, for example, 50 percent of the African American male population under 20 was over 16 and 80 percent of those over 20 were under 40, the level of eligible African American male participation in the Revolutionary War would be nearly 43 percent.

- ✓ 60 African Americans served in Col. Humphrey's Colored Troops.
- ✓ African Americans served in at least the 1st through 9th Connecticut Regiments and many other units, including the Continental Army and those associated with the names of captains and colonels.
- ✓ African Americans were privateers, marines, sailors and seamen, serving on the Brigantines Marshall, Minerva, Independence, Delight, and Defense, among others.
- ✓ At least 2 African Americans from Connecticut served in the all-black Rhode Island Regiment
- ✓ Slaves and free men served some were substitutes for their masters.
- ✓ Some African American patriots were boys, including drummers, fifers and marines.
- ✓ Some slaves received their freedom in exchange for service.
- ✓ At least 90 African American patriots are known to have applied for pensions.

It is but little wonder that when the Revolutionary War began in 1775 Connecticut's blacks were optimistic. In times of upheaval conditions change, and the black American of that era must have believed that change for him had but one way to turn – for the better. – David O. White

A RESOLUTION CONCERNING AFRICAN AMERICAN REVOLUTIONARY WAR PATRIOTS OF NEW MILFORD, CONNECTICUT AND THE PROPOSED NATIONAL LIBERTY MEMORIAL

WHEREAS, Senator Joseph Lieberman of Connecticut and Senator Charles Grassley of Iowa will introduce legislation in the U.S. Senate in May 2011 to complete the unfinished business of two decades: the construction of an entirely citizen-funded National Liberty Memorial to African Americans of the Revolutionary War at a location in the monumental core of Washington, D.C.; and

WHEREAS, from 1775 to 1783, an estimated 5,000 to 10,000 slaves and free persons served as soldiers, sailors and patriots in the Revolutionary War, including Cato Mead of Norwich, Connecticut, and later of Montrose, Iowa, while tens of thousands of men, women and children provided civilian assistance, ran away from slavery and petitioned courts and the General Assembly for freedom; and

WHEREAS, more than 800 African Americans who resided in over 80 towns and cities, and all eight counties, in Connecticut served in the Revolutionary War; and

WHEREAS, 10 African American soldiers and patriots from New Milford, including Prince Crosbee, Jess Gratis, Prince Gratis, Sip Hubbell, Thaddeus Jacklin, Jeruel Phillips, Samuel Philips, Shem, Mingo Treet, and Javan Wilson, participated in the struggle for independence; and

WHEREAS, although the original memorial was not constructed, and the authority to do so has lapsed, genealogical research and the publication of hundreds of books over more than two decades reaffirm the significant contributions made by African Americans of the post-colonial period and validates their influence on the patriotism of future generations and the movement for civil rights; and

WHEREAS, the momentum to construct a national memorial, and to finally compile a comprehensive list of African American patriots, arose in 1984 out of the quest of Lena Santos Ferguson, deceased, of our sister town of Plainville, Connecticut to honor her heritage and expand the nation's understanding of the role of African Americans in the Revolutionary War; and

WHEREAS, beginning in 1984, Rep. Nancy Johnson, Senator Lowell Weicker, and Senator Chris Dodd were leaders in the enactment and advocacy of landmark legislation, including Public Law 98-245 commemorating African American patriotism and Public Laws 99-558 and 100-265 that authorize a national memorial and declare the history of "preeminent historical and lasting significance to the nation."

WHEREAS, these combined efforts, reported by the Hartford Courant over 24 years, brought about the publication in 2008 of *Forgotten Patriots, African American and American Indian Patriots in the Revolutionary War*, which contains the longest list so far of African Americans in the Revolutionary War, NOW THEREFORE,

BE IT RESOLVED THAT THE MAYOR AND TOWN COUNCIL OF NEW MILFORD join the National Mall Liberty Fund, D.C., (<u>www.libertyfunddc.org</u>) the congressional sponsors and original cosponsors of the National Liberty Memorial Act, including Rep. Donald Payne of New Jersey and Rep. Frank Wolf of Virginia, and those who applaud the decision of Congress and President Reagan in 1988 to authorize the predecessor memorial at a site between the Washington Monument and Lincoln Memorial.

BE IT FURTHER RESOLVED that the **Mayor** and **Town Council** encourages volunteers to discover the names of still-unknown African American Revolutionary War soldiers, sailors and patriots, enlarge the body of knowledge about their lives and forward the information to National Mall Liberty Fund D.C. for inclusion in a database that will celebrate the trail blazers of New Milford together with those of hundreds of proud American communities.

BE IT FURTHER RESOLVED that the **MAYOR** and **TOWN COUNCIL** urges the Connecticut Delegation to the United States Congress to work for the enactment of the National Liberty Memorial Act and to spread knowledge of the history to institutions in Litchfield County while promoting its potential for understanding and unity throughout the nation.

BE IT FURTHER RESOLVED that the Clerk of the Town of New Milford forward certified copies of this Resolution to the entire Connecticut Delegation to the United States Congress, the Governor of the State of Connecticut, the Speaker and President Pro Tem of the General Assembly and the local superintendent of schools, librarian and historical society.
