A. Budget 2011-2012

The Director reported that the Agency's budget is on track for the 2011-2012 year. The Latchkey Account will be able to reimburse the town \$33,000 to cover benefits and still be in the black. Maxx is on track budget wise and the farm has about a \$400.00 surplus.

The Friends of Sullivan Farm signed the contract, so the Youth Agency is out of the farm. We expect to get some income from the sales of syrup.

G. Grad Party


We are participating as a 50's diner. The artwork that has been done is great and we will be serving coffee, espresso, cookies, etc and applying temporary tattoos to the grads.

Program Update: 5/14/12

1. Juvenile Review Panel

The Juvenile Review Panel currently has 15 open cases. The panel last met on Tuesday April 17th. The next scheduled Panel meeting is Tuesday May 15th, 2012 and there are 7 new cases for deposition. A current schedule of meetings for 2011-12 is posted in the main office at the Youth Agency.

Open Cases:

Case 1 (Male): Offense: Criminal Mischief 3rd

Restitution: Attend counseling sessions with a focus set on family communication, anger management, and decision making. The number of sessions will be determined by the counselor/therapist. In addition, 20 Hours of community service at a non-profit, public service agency in New Milford.

Case 2 (Male): Offense: Breach of Peace, Reckless Endangerment 2nd Degree

Restitution: Letter of apology addressed to the victim offering financial restitution for damages done. Also, have current therapist create an action plan to address skills in social etiquette and respect for others.

Case 3 (Female): Offense: Breach of Peace

Restitution: Complete 20 Hours of Community Service at a non-profit agency in New Milford

Case 4 (Male): Offense: Illegal Possession of Marijuana

Restitution: Continue current treatment sessions with his counselor until the goals that have been determined by his counselor have been met.

Case 5 (Male): Offense: Criminal Mischief 3rd

Restitution: Attend counseling sessions with a focus set on family communication, anger management, and decision making. The number of sessions will be determined by the counselor/therapist. In addition, 20 Hours of community service at a non-profit, public service agency in New Milford.

Case 6 (Male): Offense: Breach of Peace

Restitution: Research an article/book that explains the dynamics of Bullying and gives strategies on dealing with Bullying behavior. Complete a 2 page report to the panel on the findings.

Case 7 (Male): Offense: Breach of Peace

Restitution: Complete 20 Hours of Community Service at a non-profit agency in New Milford

Case 8: (Male): Operating Motor Vehicle without a License

Restitution: Complete parents program of paying back damages to their car. Obtain a current Psychological Evaluation and provide the results to his case manager. Meet with school counselors and teachers to design a plan of action to get his grades up. Find an afterschool interest and take part in planned group activities (examples: volunteer, work, club, sport).

Case 9: (Female): Possession Weapon on School Grounds

Restitution: 1. receive a re-evaluation of current medications and provide her caseworker a copy of any findings and/or recommendations from her doctor. Complete any follow-up to the recommendations that the Panel may have regarding changes to prescriptions. 2. Continue attending sessions with her Counselor. A schedule of meetings is required to be provided to her caseworker by the end of each month. The duration of the Juvenile Review Panel contract will be determined by counselor/therapist recommendations.

2. Drug Prevention Council

Schaghticoke Middle School hosted a Health Fair on Wednesday April 11 from 7:30am-2:00pm. I worked with Scott Hoffman, who is a Health Teacher at the school, to give support and feedback on the development of the day's activities. The Drug Prevention Council funded the catering costs for lunch for all of the providers in attendance at the event. Stacey and Alison worked the tables during the event. ***Please see attached thank you notes from SMS.***

Drug Take Back Day: The Drug Prevention Council, in conjunction with New Milford CTriad and the New Milford Police Department will be hosting a community

Take Back Day on June 2nd. People will have the opportunity to clean out medicine cabinets and other areas of their homes and deliver them to our location and have the prescriptions disposed of in a safe/environmentally responsible manner by DEA (Drug Enforcement Administration) representatives. Please see attached flyer which is being distributed throughout the community.

"The Drug Enforcement Administration (DEA) has scheduled another National Prescription Drug Take-Back Day which will take place on Saturday, April 28, 2012, from 10:00 a.m. to 2:00 p.m. This is a great opportunity for those who missed the previous events, or who have subsequently accumulated unwanted, unused prescription drugs, to safely dispose of those medications.

Americans that participated in the DEA's third National Prescription Drug Take-Back Day on October 29, 2011, turned in more than 377,086 pounds (188.5 tons) of unwanted or expired medications for safe and proper disposal at the 5,327 take-back sites that were available in all 50 states and U.S. territories. When the results of the three prior Take-Back Days are combined, the DEA, and its state, local, and tribal law-enforcement and community partners have removed 995,185 pounds (498.5 tons) of medication from circulation in the past 13 months.

"The amount of prescription drugs turned in by the American public during the past three Take-Back Day events speaks volumes about the need to develop a convenient way to rid homes of unwanted or expired prescription drugs," said DEA Administrator Michele M. Leonhart. "DEA remains hard at work to establish just such a drug disposal process, and will continue to offer take-back opportunities until the proper regulations are in place."

"With the continued support and hard work of our more than 3,945 state, local, and tribal law enforcement and community partners, these three events have dramatically reduced the risk of prescription drug diversion and abuse, and increased awareness of this critical public health issue," said Leonhart. " www.dea.gov

Yard Sign Campaign: The Council will be working with local liquor stores to distribute any remaining yard signs into the community. With Prom and Graduation coming, May and June are important months in the battle against underage drinking within our town. Community members will be able to take the signs for their yards and spread the message of "I Am a Parent First, No Underage Drinking Parties Hosted Here."

4. Counselor Update:

*The following groups are currently being run:

Teen Girls Group: Every Friday September – June. For teens grades 9-12. Topics include self esteem, healthy relationships, Nutrition, and Substance Abuse. Currently there are 10 girls enrolled in the program.

6th Grade Group: Held at the Maxx on every other Tuesday. The kids learn social skills and self esteem building through fun activities. There are currently 6 students enrolled in this group.

7th & 8th Grade Group: Held at the Maxx on every other Tuesday. The kids learn social skills and self-esteem building through fun activities. There are currently 6 students enrolled in this program.

Family Issues Group for 4th - 6th grades. Held weekly at Sarah Noble School (during school hours). Topics include Divorce, Anxiety & Stress Management. There are 8 students in this group.

***Upcoming Groups:**

Navigating the Girl-world in Middle School: Has your middle school daughter ever been on the giving or receiving end of putdowns, rumors, or other hurtful "drama" between girls? The New Milford Youth Agency is offering a FREE one time workshop for middle school girls on Friday May 18th from 2:30-4:30 at the Maxx in downtown New Milford. Girls can come to learn practical tools for dealing with conflict, and creating more positive experiences with other girls. The Women's Center of Danbury will facilitate this interactive program along with YA counselors. Youth Agency bus transportation is provided from SMS to the Maxx- but there are limited seats! Snacks will be provided, and parents can pickup at the Maxx at 4:30. Registration is required; contact the YA @ (860) 354-0047 or email Laura@youthagency.org.

Summer Thursday group: A repeat of last year's successful free summer activity day. Meet every Thursday in summer for activities for youth entering 4-8 grade.

Summer Volunteer/Intern Program: Opportunity for high school students, entering grades 11 and 12 to take their volunteering to a more formal level by participating in a one day training, committing to a certain minimum hours, and participating in planning an activity. "Interns" will mostly work with the kids on Summer Thursdays, fully supervised by Stacey and Laura.

5. Police Grant

The Police & Youth Community Enrichment Project: This collaboration between the New Milford Youth Agency, the New Milford Police Department will provide representatives from New Milford's mainstream, and at-risk populations, the opportunity to work directly with local police officers in both a social and professional venue. The project will provide local youth the opportunity to socialize with members of the police force at the town's local teen center (the Maxx), where together they can play pool, ping pong, watch movies, and play video games together. During these sessions, the Police Officers will recruit 8-10 youth for an Enrichment team. This team will do leadership training as well work directly under the supervision of Police Officers in the construction of a new fishing dock at Sega Meadows Park, which was newly acquired by the Town of New Milford. A "Ground Breaking/Ribbon Cutting" ceremony will conclude this project.

The program will run April – June 2012: The 7 sessions of the program will be laid out as follows.

Week 1: Snaxx at the Maxx – *April 30th*
Week 2: Snaxx at the Maxx – *May 7*
Week 3: Snaxx at the Maxx – *May 14*
Week 4: Camp Sloane Leadership Training – *May 28*
Week 5: Hike - *TBD*
Week 6: Construction of Fishing Dock at Sega Meadows Park - *June*
Week 7: Ribbon Cutting Ceremony and Family Picnic at Sega Meadows – *June*

Maxx May 14th Update for April events

Maxx Advisory Board: 8 NMHS Students Attended: This group met Sunday April 29th to discuss the upcoming jazz & acoustic night logistics. Some other topics discussed was an Iron Chef night and ideas for summer programming. Most of the ground work was laid for the iron chef night and a date picked tentatively for this summer. The advisory group also talked about summer programming and some new ideas for middle school events. These ideas included new themes and prizes for dances. The final topic discussed was the Youth film festival which will be a film event lasting all weekend where area teens can send in their short films to be showcased and judged by their peers. The film festival is set for some time in August and we expect a good turnout. The advisory board's feedback was vital and a lot of good ideas came out of the meeting. Dinner and soda was provided. The next meeting will be held on May 27th.

Maxx Jazz Night – 36 people attended: The Jazz Night was a big hit among area teens which allowed different musicians to come in and play their talent in a calm relaxing setting. This was the first jazz/funk night and it brought in a whole different target audience to the Maxx. Comedy was also performed by a NMHS teen named Dustin Martin and everyone loved it. Great food was cooked by the Maxx kitchen staff and it just turned into a wonderful, successful and friendly night. The Next Jazz night is scheduled for May 18th.

Coffee House : 30 people attended the Coffee House night on April 27th. It allowed local musicians and artist to play and showcase their work in a calm relaxing setting. It was well attended and the response was great. For the upcoming May 25th coffee house night the Maxx will do another Judged art show. The Art will be judged by the students in 3 categories and the winners will receive prizes. We are hoping to get more artists and give the ones who have been showing their work a chance to win a \$50.00 Gas card

Middle School Event: 81- 6th graders & 50 7th graders attended the 2 April middle school dance. During the night there was a game night featuring 3 different games for kids to play. The winner of the games received a Wal-Mart gift card, free admission & drinks . During the dance our counselor Alison came down to help supervise and give our staff some insight and feedback on student behavior and how to appropriately handle it. Alison's feedback was well received and I would like to thank her for coming down to help. For this 7th Grade dance we continued the trial separation of 7th and 8th grades. Each Grade will have their own dance. This is again due to the over whelming attendance of kids and the feeling that the dances will be much easier to handle

and provide a safer environment if the two grades were separated. The Director and I will continue to monitor and re-evaluate this change in a couple of months to see if it is working.
